

ANNOUNCEMENT TO ALL SHAREHOLDERS

The Shareholders or their valid proxies entitled to attend the Annual Meeting shall be those whose names are recorded in the Company’s Register of Shareholders as of Tuesday, 30 May 2017 at 16:00 Western Indonesia Time.

Pursuant to Article 12 of the POJK No.32/POJK.04/2014 and Article 10 Paragraph 7 of the Company’s Articles of Association, any proposal from the Shareholders shall be submitted in writing and received by the Board of Directors of the Company at least 7 (seven) days prior to the Notice date of the Annual Meeting or by Wednesday, 24 May 2017.
